AUTHORIZING THE FILING OF AN APPLICATION FOR FINANCIAL ASSISTANCE FROM THE STATE INFRASTRUCTURE BANK IN AN AMOUNT NOT TO EXCEED FOUR MILLION THREE HUNDRED TWENTY-FIVE **THOUSAND** (\$4,325,000) AS THE CITY'S PARTICIPATION AND CONTRIBUTION TO A JOINT PROJECT WITH THE TEXAS DEPARTMENT OF TRANSPORTATION AND SPECIFICALLY THE CONTRIBUTION OF RIGHT OF WAY FUNDS FOR THE SEGMENTS FROM EAST CORRIDOR RD (AIRPORT) TO 0.36 MILE SOUTH OF UNIVERSITY BLVD, FROM 0.36 MILES SOUTH OF UNIVERSITY BLVD TO 0.51 SOUTH OF SHILOH DR. AND FROM 0.51 MILES SOUTH OF SHILOH DR. TO INTERNATIONAL BLVD, AND AUTHORIZING THE CITY MANAGER TO ACT ON BEHALF OF THE CITY OF LAREDO IN ALL MATTERS RELATING TO THE APPLICATION AND **PARTICIPATION**

WHEREAS, the State Infrastructure Bank, operated by the Texas Department of Transportation, is a revolving loan fund; and

WHEREAS, the City of Laredo ("the City") deems it proper and in the best interest of the City to apply for a loan from the State Infrastructure Bank in the amount not to exceed of \$4,325,000 to be used to finance the City's participation and contribution to a joint project with the with the Texas Department of Transportation for highway improvements on North US 59 Loop (formerly known as State Loop 20 and Bob Bullock Loop), specifically the contribution of Right of Way funds for the segments from East Corridor Rd (Airport) to 0.36 Mile South of University Blvd (RCSJ# 0086-14-091), from 0.36 miles South of University Blvd to 0.51 South of Shiloh Dr. (RCSJ-086-14-092) and from 0.51 miles South of Shiloh Dr. to International Blvd. (RCSJ 086-14-093); and

WHEREAS, the City is qualified to apply for and obtain financial assistance from the State Infrastructure Bank for this purpose;

Section 1: The City Manager is authorized for filing of an application for financial assistance from the State Infrastructure Bank in the amount no to exceed of Four Million Three Hundred Twenty-Five Thousand (\$4,325,000) as City's participation and contribution to a joint project with the with the Texas Department of Transportation for highway improvements on North US 59 Loop (formerly known as State Loop 20 and Bob Bullock Loop), specifically the contribution of Right of Way funds for the segments from East Corridor Rd (Airport) to 0.36 Mile South of University Blvd (RCSJ# 0086-14-091), from 0.36 miles South of University Blvd to 0.51 South of Shiloh Dr. (RCSJ-086-14-092) and from 0.51 miles South of Shiloh Dr. to International Blvd. (RCSJ 086-14-093).

<u>Section 2:</u> The City Council hereby authorizes the City Manager of the City of Laredo to execute an application for financial assistance from the State Infrastructure Bank and to submit the application together with all required documentation to the Texas Department of Transportation for consideration. The City Manager is authorized to act on behalf of the City of Laredo in all matters relating to the participation.

Section 3: This resolution shall become effective as and from the date of final passage.
