- B. Receive public testimony and initiate a 10-day public review and comment period for the following proposed amendment(s) of the 2021-2024 Transportation Improvement Program (TIP):
  - Addition of project CSJ 0922-33-213 intended to provide for preliminary engineering and construction for the expansion of existing World Trade Bridge. The estimated construction cost is \$12,000,000 with an estimated total project cost of \$16,000,000. The project sponsor is the City of Laredo and the proposed letting date is FY 2024.
  - 2. *Revision* of project CSJ 0922-33-166 for the construction of Hachar-Reuthinger Road. *Purpose* of amendment is to update the project description to read "new location construction of 4-lane divided highway" to adequately describe the initial construction phase(s).
  - 3. *Revision* of project CSJ 0922-33-165 for the construction of Hachar-Reuthinger Road. *Purpose* of amendment is to update the project description to read "new location construction of 4-lane divided highway" to adequately describe the initial construction phase(s).
  - 4. Revision of project CSJ 0922-33-165 for the construction of Hachar-Reuthinger Road. Purpose of amendment is to revise the existing funding amounts. Funding amounts will be adjusted to increase Category 7 funds from \$26,796,901 to \$28,431,178 and add \$2,341,935 allocated to the project through Coronavirus Response and Relief Supplemental Appropriation Act (CRRSAA) funds.

- 5. *Revision* of project CSJ 0086-01-073 for the widening of SH 359. *Purpose* of amendment is to revise the existing funding amounts. Funding amounts will be adjusted to include \$7,000,000 in category 11 funds.
- 6. *Revision* of project CSJ 0086-14-089 for the reconstruction of existing 6-lane highway to proposed 6-lane freeway with 3-lane frontage roads. *Purpose* of amendment is to revise the existing funding amounts. Funding amounts will be adjusted to include \$2,605,222 in category 11 funds and decrease category 10 funds from \$9,000,000 to \$4,285,269.
- 7. *Revision* of project CSJ 0086-14-088 reconstruction of existing 6-lane highway to proposed 6-lane freeway with 3-lane frontage roads at University Blvd. to Shiloh Dr. *Purpose* of amendment is to revise the existing funding amounts. Funding amounts will be adjusted to replace \$11,500,000 in category 4 funds with category 2U funds, increase category 10 funds from \$8,500,000 to \$22,000,000, and include \$11,894,778 in category 11 funds.
- Revision of project CSJ 0086-14-079 for the construction of US 59 interchange at University Blvd. *Purpose* of amendment is to revise the existing funding amounts. Funding amounts will be adjusted to include \$2,514,639 in category 10 funds.
- Revision of project CSJ 0086-14-076 for the construction of US 59 interchange at Shiloh Dr. Purpose of amendment is to revise the existing funding amounts. Funding amounts will be adjusted to include \$10,356,549 in category 10 funds.
- Revision of project CSJ 0086-14-075 for the construction of US 59 interchange at Del Mar Blvd. Purpose of amendment is to revise the existing funding amounts. Funding amounts will be adjusted to include \$4,346,123 in category 10 funds.
- Reprogramming of project CSJ 0018-06-185 for the construction of a new direct connector (#3) south I-35 to east I-69W. Purpose of amendment is to remove this project from the 2021-2024 TIP as the updated letting date for this project has been changed to FY 2026 and is outside of the current TIP years.
- Revision of project CSJ 0086-14-086 for the reconstruction of existing 6-lane divided highway to proposed 6-lane freeway facility with a section including 3-lane frontage roads from US 59 to 0.4 miles north of E. Corridor Rd. (airport). *Purpose* of amendment is to revise the existing funding amounts. Funding amounts will be adjusted to increase category 12 funds from \$15,600,000 to \$29,290,676.

- Revision of project CSJ 0086-14-078 for the construction of US 59 interchange at Jacaman Rd. Purpose of amendment is to revise the existing funding amounts. Funding amounts will be adjusted to increase category 12 funds from \$17,000,000 to \$21,742,567.
- 14. *Revision* of project CSJ 0086-14-077 for the construction of US 59 interchange at airport. *Purpose* of amendment is to revise the existing funding amounts. Funding amounts will be adjusted to include \$16,418,996 in category 12 funds.
- 15. Administrative Amendment of project CSJ 0922-33-181 to improve connections, accessibility and security for up to 17 bus stops. Purpose of amendment is to revise the estimated letting date from fiscal year (FY) 2022 to FY 2023. This project letting date revision is listed for informational purposes only as moving a letting date within the TIP years does not require a formal revision.
- 16. Administrative Amendment of project CSJ 0086-02-023 for the widening of SH 359 from 8.935 miles east of SL 20 and 9.830 miles east of SL 20. Purpose of amendment is to adjust the ROW purchase cost information. Change in ROW cost information does not require a formal revision.

Mr. Mendive, MPO Interim Director gave a quick overview of the 2021-2024 TIP and STIP revision process and read all the proposed amendments.

Mayor Saenz stated he would like to abstain from any project located along Hwy 359 (Item 5 and Item 16) as he owned property in the area.

David Salazar, TxDOT, provided a brief overview of the reasons behind the proposed amendments.

Judge Tijerina asked if for item 1 a Presidential permit was needed. And, if so, what was the reason the item was included in the list.

Mr. Mendive explained this was a project being sponsored by the City of Laredo that will seek Federal funding allocations and the 1<sup>st</sup> step was to list it in the current TIP.

Mr. David Salazar continued with the quick summary of the proposed amendments.

Judge Tijerina asked what was the total amount for these items.

Mr. Salazar and Mr. Gonzalez from TxDOT responded it was approximately a total of \$34.1M in Category 12 that was approved in the UTP 2022 and \$21.5M in Category 11 from TXDOT funds. Both projects were already in the STIP and some with environmental clearances completed.

Juan Mendive, MPO Interim Director stated the addition of the expansion to World Trade Bridge project to the MPO documents was an important step for FHWA be able to participate in the development of the project.

Sid Mielke, Structural Engineering Associates (SEA), stated that the rules for the permitting have changed in early 2019. He stated there was executive ordered issued that altered the way how presidential permits were reviewed and issued and also how the environmental clearances were issued and the timing for it. When the executive order was issued, the requirement for the Department of State to be the authority over the environmental clearance of a project was removed. It also reversed the order in which the environmental clearance was to be done relative to the presidential permit. And, it allowed the presidential permit application be submitted up front and be approved with the agreement that all other permitting would be done. It did not define who would be the responsible agency on the federal side for the environmental clearance. He stated they had been in discussions with Federal Highway and they had agreed to be the federal reviewer of the environmental assessments for projects that require presidential permits. However, in order for them to participate, any project would have to be listed within the TIP and the STIP for the state. It would also have to have a small amount of funding assigned to it that would allowed them to participate.

Mr. Salazar, TxDOT, stated the design was moving forward and the environment clearance should be cleared by December.

#### V. REPORT(S) AND PRESENTATIONS (No action required).

A. Status report by the Regional Mobility Authority (RMA).

Jed Brown, RMA, stated that there were four additional members of the RMA present at the meeting. He further stated that in the packet there was a status report of seven projects and he was available for any questions. The report read as follows:

- FM 1472 and Killam Industrial Blvd. Turn Lanes NTP for the contractor was provided by TxDOT at the end June. Currently, Anderson Columbia is working from Big Bend to South of Killam Industrial Blvd. The Killam Turn Lanes portion of the project and the northern portion of the project began on the week of the 7<sup>th</sup> of December. TxDOT notified us on 1/11/22, that have pulled away from the work at Killam Industrial Blvd. and FM 1472. Their current focus of work is in the area of Milo and FM 1472. We did not receive a time for commencement of work a Killam Industrial Blvd. at FM 1472.
- Los Presidentes (Cuatro Vientos to Brownwood) Construction is ongoing. Our 6<sup>th</sup> construction progress meeting was held on 1/13/21. Currently, the project is scheduled for completion in 6/24/2022. <u>The project is 60% complete</u>. By phase, Phase 1 is 50% complete and Phase 2A is 80% complete. Regarding the Cuatro Vientos Acceleration/ Deceleration Lane project, the project was awarded to Anderson Columbia in October 2021. We anticipate construction to commence in early 2022.

- Springfield Phase III NTP was provided by the City of Laredo to AZAR Services, LLC on 12/15/21. Since NTP, clearing and grubbing of the project corridor has commenced. The City anticipates a construction progress meeting for the first week of February. Substantial completion is scheduled for 8/29/2022.
- 4. Webb County Fair Grounds TIA The RMA team met with the TxDOT Laredo District to discuss future plans for US 59. Tentatively, upgrade of US 59 to IH 69W could begin by 2032 as part of the Ports-to-Ports Initiative. The RMA team also met with the County Consultant, Mr. Judd Gilpin. He informed the team that the current master plan for the Fair Grounds is being revised. The updated master plan is tentatively scheduled to be released by February 2022. Overall, timeframe for completion of the study is the end of 2022.
- 5. River Road Implementation Study Awaiting next steps in funding approval to proceed.
- Loop 20 South (Cuatro Vientos) TRZ Study Update In the January 19th RMA meeting the Board approved entering into an ILA with the City of Laredo to update the 2018 Cuatro Vientos TRZ study with current 2021/ 2022 data.
- Vallecillo Road We are continuing to communicate with officials from the Texas Transportation Commission and higher regarding the importance of the project to the Laredo Greater Area and the State.

Other Items:

- The WCCL RMA conducted a Transportation Reinvestment Zone Workshop for the full WCCL RMA Board, members of City Council, members of Commissioners Court and members of the MPO staff on 12/17/21.
- The WCCL RMA conducted the January Board meeting on 1/19/22.
- The WCCL RMA Project Report for 2021 will be distributed to members of the Policy Committee this month.
- B. Update by City of Laredo Engineering staff on the FM 1472/Flecha Ln. Realignment (CSJ 0922-33-076) and Calton Road Grade Separation (CSJ 0922-33-093) projects listed in the 2021-2024 Transportation Improvement Program (TIP).

Ramon Chavez, City Engineer, stated that a status report was included as part of the packet and introduced Ms. Gloria Perez-Saavedra who gave a presentation on the status of both projects. She stated she would be available for any questions.

C. Discussion and review of TxDOT's FY 2023 Unified Transportation Program (UTP) and unfunded projects, and discussion on the survey of MPO Technical and Policy Committee members regarding the ranking of unfunded projects.

Humberto "Tito" Gonzalez stated Roberto Rodriguez, TxDOT, was going to provide a brief scope and description of the projects.

Roberto Rodriguez gave a brief presentation of the item and went over the list of unfunded projects.

Mayor Saenz left the meeting at approximately 2:43 p.m.

Mr. Mendive stated that he would send out a survey to the MPO Policy and Technical Committee members and to consider how the projects improve safety, reduce congestion and promote mobility equity in the region.

Mayor Saenz joined the meeting at 1:40 p.m.

Judge Tijerina stated that the latest Laredo Bridge System Master Plan study he has from 9/23/2021 has never been presented to the MPO committee. He stated, one of the concerns he had in regards to the expansion of the World Trade Bridge was that that on page 201 of the study it stated that the alternative did not provide an improvement to reduce congestion at the Point of Entry (POE) regarding total volume through crossings and waiting times. He further stated that besides the project going from \$12M to \$16M, he did not understand why the MPO would keep pushing for said project when in reality, the monies could be used somewhere else. He also stated that if the outcome of the studies that usually cost \$400K-\$500K, is not going to be taken into consideration, then it was an injustice for the people of Webb County and the City of Laredo for spending of monies that we might not have to.

Mayor Saenz briefly provided his comments about the proposed expansion of World Trade bridge and the proposed construction of bridge 4-5. He further asked the consultant to approach the podium to elaborate on the topic.

Sid Mielke, Structural Engineering Associates, stated that the purpose for the City to have brought the project to the MPO was because the rules have changed relative to presidential permitting and it would apply to any presidential permit that has or will be issued in the coming future. He continued stating that with the changing of the rules in 2019, there were some changes on the way presidential permit issues were developed and it was not defined which agency was going to be the lead agency for environmental clearance. After an investigation some years ago, it was determined that Federal Highway Administration was willing to step forward and be the lead agency for the environmental clearance for an international bridge project. GSA or CBP did not desire to be in that role. Therefore, in order for Federal Highway Administration to be a part of an international bridge project, there has to be a methodology for the federal highways to be able to participate. Such methodology was determined in coordination with dealing with federal highways that a small sum of federal construction money would be assigned to the project. This allowed the Federal Highway Administration to take the role to be the lead and reviewers for the environmental clearance process. He further mentioned that he agreed that the expansion of the bridge itself if nothing changes, it won't help the port processing more vehicles but all the projects ongoing that are planned and some already funded will contribute to the expansion of processing through World Trade Bridge.

David Salazar, TxDOT, stated that he is aware of the \$1M already setting aside for this \$16M project but, if a year goes by and the project is not funded, he asked if the project would then be removed from the Unified Transportation Plan (UTP). He also stated this would be a good time to be looking as to where the rest of the monies will come from.

Mr. Mielke stated that the City of Laredo stated publicly that all of the remaining funds would be funded through the City of Laredo. He stated that the City of Laredo had already identified all the funding and was already stated in the presidential permit application. He stated that this participation of funding was needed for the Federal Highway to be the reviewer of the environmental clearance for the project. He further explained that the bridge currently has 8 lanes total and the proposed expansion will bring another 8 lanes and the expansion will improve the processing time of trucks through World Trade Bridge.

Yvette Limon, Bridge Director, stated all three projects combined and all the efforts that TxDOT was doing outside of the Loop would increase the flow through the port. She stated all the trucks that enter the port do not necessarily go straight to the exit. There are processes that happen within the port that would allow an even flow to the exit and out on to Loop 20 I-69 west. The new expansion project would allow Custom Border Projection (CBP) to process non-fast, non cp pad cargo shipments.

Mr. Mielke stated to conclude his participation that what they recommended to the City and the City is asking the MPO for this project to be listed the current TIP, the MTP and the allocation of up to \$1M dollars for FHWA be able to review the environmental clearance.

Jose Ceballos stated he was there to ask the MPO committee to support the resolutions as revisions to the 2021-2024 TIP and, was also in support of items IV-A-1, 2, 3, and 4 as well as the revision to the 2020-2045 MTP, item IV-B-1 supporting the expansion of the World Trade Bridge.

Judge Tijerina left the meeting at approximately 2:35 p.m.

Purpose: Aquero Blvd. (River Road) Planning Study Background and Overview

- 1. The North Laredo Webb County Planning Study that was jointly funded by the RMA and the Laredo MPO Coordinated Border Infrastructure Funds (FHWA) via an Advanced Funding Agreement with the TxDOT Laredo District was completed in March 2020. (*Note: This is the only study that has been jointly funded by the WCCL RMA and the Laredo MPO*).
  - A final presentation was provided to the Laredo MPO Policy Committee in February 2020.
  - The North Laredo Webb County Planning Study is the **Master Plan for the North Area** as the limits of the Study span from North of IH 69-W to SH 255 and is bounded by the Rio Grande to the West and IH 35 to the East. It provides the following:
    - > A list of projects to implement from 2021 to 2040 that will improve mobility in that entire region.
    - A schedule of when each project should be constructed over the 20-year time frame.
    - An order of magnitude construction cost estimate for each project (accounting for inflation for the forecasted construction time).
    - > A map depicting all of the master plan improvements.
- 2. Per the schedule in the North Laredo Webb County Planning Study, the planning phase for Aquero Blvd. (River Road) would commence in 2021/2022. (*Note that the Laredo MPO funded a 2006 Study that spanned from south of Bridges 1 and 2 to FM 1472*). The study for Aquero Blvd. (River Road) would consist of the following:
  - Develop a final alignment of the roadway project and determine the traffic benefits for the surrounding area. The study will investigate 2 possible alignment routes and a No-Build option.
    - Alignment will be developed with stakeholder (Private Landowners, City of Laredo, Webb County, LPD, LFD, UISD, CBP, etc.) input via workshops and public meetings
    - Environmental Constraints Mapping and Analysis to identify areas of concern to avoid in the alignment (archaeological, biological, cultural, waters of the US, etc.).
    - Traffic Analysis to determine the benefits of the movement of traffic to the surrounding roadways such as FM 1472, Killam Industrial Blvd., River Bank Road, etc.
  - Total duration of study would be 12 months.
  - Next steps after the study would be to develop a roadway schematic for environmental clearance, identification and acquisition of ROW and identify utility conflicts.
- 3. Cost and Funding of the Aquero Blvd. (River Road) Planning Study

- Study Cost is \$250K
  - Project Management \$25K
  - Environmental Constraints Mapping and Analysis \$15K
  - > Public Involvement and Stakeholder Workshop \$70K
  - > Traffic Analysis and Cost Estimating \$70K
  - Corridor Analyses and Report \$70K
- Study Funding
  - > WCCL RMA \$125K
  - Laredo MPO \$125K
- 4. The Aquero (River Road) Corridor Study can be performed with a consultant that has been procured via a Professional Services Request for Qualifications (RFQ) pursuant and in compliance of the Texas Procurement Act.
  - WCCL RMA can advertise an RFQ for 30 days and negotiate a contract with a consultant specific for this Study.
    - Oversight of the consultant would be performed by the WCCL RMA General Engineering Consultant (HNTB Corporation)
    - Duration of time between WCCL RMA Board of Directors Approval of the RFQ advertisement, advertisement duration, consultant selection, contract negotiation and award would be about 90 days.
  - WCCL RMA can also utilize the GEC to perform the study. The GEC was procured in 2015 via an advertised RFQ process pursuant and in compliance of the Texas Procurement Act.
    - WCCL RMA GEC has performed a similar function in the past to develop the North Laredo Webb County Transportation Planning Study.
    - The question of the GEC being able to perform the study which was funded with CBI (federal dollars) was discussed by the Laredo MPO in the March 2018 and April 2018 Policy Committee Meetings.
      - WCCL RMA Legal Counsel, Juan Cruz of J. Cruz and Associates provided a presentation to the Policy Committee in April 2018 describing the Texas Procurement Act and the RFQ process that the WCCL RMA followed to select and contract the HNTB Corporation as their GEC.
      - The Laredo MPO Policy Committee passed a motion in April 2018 authorizing the WCCL RMA and the MPO to enter into an agreement to conduct the North Laredo Webb County Transportation Planning Study with an 80/ 20 cost sharing between the Laredo MPO and the WCCL RMA. The vote passed unanimously with all present 6-0.
      - The Laredo MPO Policy Committee revised the motion in May 2018 to simply allocate the CBI funds for the North Laredo Webb County Transportation Planning Study, pending an execution of an Advanced Funding Agreement between TxDOT and the WCCL RMA with the cost being divided 80% via CBI funds and 20% via RMA funds. The vote passed unanimously with all present 7-0.

- FM 1472 and Killam Industrial Blvd. Turn Lanes NTP for the contractor was provided by TxDOT at the end June. Currently, Anderson Columbia is working from Big Bend to South of Killam Industrial Blvd. The Killam Turn Lanes portion of the project and the northern portion of the project began on the week of the 7<sup>th</sup> of December. TxDOT notified us on 1/11/22, that have pulled away from the work at Killam Industrial Blvd. and FM 1472. Their current focus of work is around Milo and FM 1472. The commencement of work a Killam Industrial Blvd. at FM 1472 will occur in May 2022.
- Los Presidentes (Cuatro Vientos to Brownwood) Construction is ongoing. Our 7<sup>th</sup> construction progress meeting was held on 2/15/22. Currently, the project is scheduled for completion in 6/24/2022. <u>The project is 60% complete</u>. By phase, Phase 1 is 50% complete and Phase 2A is 90% complete.
- 3. Loop 20 South (Cuatro Vientos) Acceleration/ Deceleration Lane Project The project was awarded to Anderson Columbia in October 2021. Construction to commence on the week of the 14th of March.
- 4. Loop 20 South (Cuatro Vientos) TRZ Study Update Awaiting approval of the Interlocal Agreement with the City of Laredo. Upon approval, work will commence on the TRZ Study.
- Springfield Phase III NTP was provided by the City of Laredo to AZAR Services, LLC on 12/15/21. Since NTP, clearing and grubbing of the project corridor has commenced. The first progress meeting occurred on 2/16/22. Substantial completion is scheduled for 8/29/2022.
- 6. Webb County Fair Grounds TIA The RMA team met with the TxDOT Laredo District to discuss the future plans for US 59. Tentatively, upgrade of US 59 to IH 69W could begin by 2032 as part of the Ports-to-Ports Initiative. The RMA team also met with the County Consultant, Mr. Judd Gilpin. He informed the team that the current master plan for the Fair Grounds is being revised. The updated master plan is tentatively scheduled to be released by April 2022. The Team is focusing on the existing conditions model for the study. Traffic Counts and Traffic Movement Data was collected on 3/4 and 3/5 during the Laredo International Fair and Expo. Overall, timeframe for completion of the study is the end of 2022 to early 2023, depending on the availability of the updated master plan.
- River Road Corridor Study The Technical committee recommended placing the Study on the March MPO Policy Committee Agenda for Discussion and Possible Action. Upon approval by the MPO Policy Committee to partner with the RMA, the RMA will commence work on the Study. Duration of the study is estimated for 12 months.
- 8. Vallecillo Road We are continuing to communicate with officials from the Texas Transportation Commission and higher regarding the importance of the project to the Laredo Greater Area and the State.
- 9. Other Items:
  - The WCCL RMA will conduct its March Board Meeting on 3/25/22.









#### Director's Report March 16, 2022

- 1. The audit of the Laredo Webb County Area MPO by TxDOT is ongoing. An entrance conference was held on January 14, 2022. The fieldwork is scheduled through the end of March, with a report release tentatively scheduled for April 2022.
- 2. The MPO Process Review is nearing completion. Bill Frawley of the Texas A&M Transportation Institute (TTI) was in Laredo from March 8<sup>th</sup> through March 10<sup>th</sup>. During his visit we met with the City of Laredo Finance Director and Interim Human Resources Director to discuss final details in preparation of a Memorandum of Understanding between the MPO and the City of Laredo (Fiscal Agent). We are also working with the HR Department to finalize a job description, create a position for the permanent fulltime MPO Director, and determine the appropriate classification.
- 3. The El Metro Comprehensive Operation Analysis (COA) was adopted by the Mass Transit Board on February 22, 2022. MPO and El Metro staff will continue collaborating to help implement the recommendations of the COA. Additionally, we will continue to work closely with El Metro in our planning efforts to promote transit and improve multimodal mobility in our region.
- 4. MPO staff is working with TxDOT Transportation Planning and Programming Traffic Analysis and TTI staff to develop our Travel Demand Model with a base year of 2018 and a forecast year of 2050 as part of the next Metropolitan Transportation Plan (MTP) update.
