1. **Public Hearing and Introductory Ordinance** for the adoption of a tax rate of \$0.570000 per \$100 value for Tax Year 2022. The tax rate will provide revenue for the general fund and debt service. The rate includes \$0.449396 per \$100 value for Maintenance and Operation and \$0.120604 per \$100 value for Interest and Sinking Fund of the Debt Service and is estimated to generate a tax levy of \$105,637,719. The City Council is scheduled to vote on the tax rate on September 19, 2022 at 5:30 PM at City Council Chambers located at 1110 Houston Street, Laredo, Texas.
